\$235/month for 10 months (September to June)

Policies:

- No proration of tuition.
- Students who withdraw from the program must give a 30-day notice and will be charged through the end of the month they withdraw. Notifications must be submitted via email.
- \$35 registration fee will be charged at the time of registration. This fee is waived for current Infinity families.
- \$75 supply fee will be charged at the time of registration.
- The supply fee and registration fee are required in full to hold each child's spot in class and are both nonrefundable.
- Tuition is due on the 1st of each month and is considered late on the 10th. Students who pay on the 10th or later will be charged a 10% late fee and are subject to removal of the preschool program.
- We communicate all important information via email. If you require a different form of communication, please let us know at the time of registration.
- Parents are expected to pack their child a snack each day. Infinity will not provide student snacks during preschool hours.
- Sibling and multiple class discounts do not apply to the Infinity preschool.
- Price of tuition includes Kindermusik materials for the home.
