

# Infinity Dance Company Registration Form

Welcome and thank you for joining Infinity Dance Company! We hope your year is filled with creativity, inspiration, motivation and fun! To help make this the best experience possible, please read through the important information below THOROUGHLY.

A. **REGISTRATION FEE:** \$20/student/session due at the time of registration.

B. **TUITION:** Students will be charged tuition for 3.5 months for Fall Session, 5.5 months for Spring Session and 1 month for Summer Session. Tuition is due on the 25<sup>th</sup> of the month prior to when classes are taken. Payments made on the 5<sup>th</sup> of the month or later will be charged a 10% late fee. Any tuition unpaid by the 20<sup>th</sup> of the month will result in the removal of your child from all classes until tuition is made current. **NO PRORATION** of classes Fall Session, Spring Session, Workshops, Master Classes or Intensives. When signing up for a session, students are committing to pay tuition for the duration of the session, as stated above, regardless of whether a student drops a class. Proration accepted Summer Session by director approval only and in writing prior to the session start date. Tuition can be paid in the office or online through [dancestudio-pro.com](http://dancestudio-pro.com). See page 2 for tuition details.

C. **PRODUCTIONS:** There are two productions per year, December (at the end of Fall Session) and June (at the end of Spring Session). There is no production at the end of Summer Session. Students who desire to be in the production must attend a minimum of  $\frac{3}{4}$  of their weekly classes. If a student misses more than  $\frac{3}{4}$  of their class, their teacher may request the student not perform or have private lessons to better learn the choreography. **ALL ACCOUNTS MUST BE CURRENT BY THE LAST DAY OF THE CURRENT SESSION IN ORDER FOR RECITAL PARTICIPATION.** Tickets for productions will be available for purchase in office the month before the production. All ticket sales are final. **NO REFUNDS WILL BE GIVEN.**

D. **PRODUCTION FEES:** Each performing class will be charged a performance fee that will cover the cost of a costume rental. Students must provide their own undergarments, shoes and tights. Some, but not all, of the costumes may be available for purchase at an extra fee. Fall Session performance fees must be paid by September 15<sup>th</sup>, Spring Session performance fees must be paid by January 15<sup>th</sup>. If payments are made late, production participation is not guaranteed and students may be charged extra for shipping and handling. For performance fee rates, see page 2. Performance fees and costume purchases are **NON-REFUNDABLE UNDER ANY CIRCUMSTANCE.** Students who damage their costume will be charged the full amount of the costume.

E. **CLASSROOM ATTIRE AND ETIQUETTE:** Students are expected to follow classroom attire set by the instructor. A complete list of instructor approved classroom attire will be posted on Infinity Dance Company's website at least one week prior to the beginning of the session. Students are expected to behave in a manner that is appropriate and positive at all times. Questionable or inappropriate behavior may result in the child being removed from the class or studio.

F. **CLASS PLACEMENT:** At the end of each session the instructors will discuss with each other and the director where students should be placed the following session. Placements will be emailed **ONLY IF THE STUDENT'S PLACEMENT HAS CHANGED.**

G. **MISSED CLASSES:** Students are welcome to make up missed classes in another age appropriate class. Make ups must be scheduled with the studio director. This does not include a private lesson. Private lessons are an additional charge.

H. **PRIVATE LESSONS:** Private lessons are a great way to catch up on missed choreography or to improve your skills! The cost is \$60 for one hour and \$30 for a half hour. All private lessons must be scheduled through the office or studio director, not the instructor. Parents are required to stay for the duration of the lesson if no other staff member is in the building.

I. **PARENT AND STUDENT COMMUNICATION:** We communicate all important information and updates through email. If you do not check your email and require a different form of communication, please mark this on your registration form.

J. **PICTURE DAY AND PHOTOGRAPHY:** There will be two picture days per year, one in Fall Session and one in Spring Session. Participation is appreciated in picture day even if you are not purchasing a photo. Photos of each production's dress rehearsal will also be available for purchase as well as videos of each production. All parents are free to take their own pictures and videos on dress rehearsal only. No pictures/videos will be allowed backstage. All photos/videos used by Infinity Dance Company for the purpose of advertising, will be at the consent of the parent. If you give consent for studio photos/videos of your child to be used for studio advertising, please sign the photo/video release on page 4.

K. **VOLUNTEERING:** To give the best possible productions and protection for your children, it is important we have volunteer support. On average for a production it can take up to 100 volunteers! By registering your child at Infinity Dance Company, you and your family are **COMMITTING** to help with picture day, productions, dress rehearsal, costumes, publicity, studio maintenance or other volunteer areas each session. Your commitment and support is appreciated!
